Terms and Conditions for Application of Boat Vehicle Operator Permit

My signature on the application certifies that I have received the pass/card and that I have read and consent to the conditions below:

- 1. The items issued to me are the property of Kamloops Airport Ltd. and will be surrendered without delay by me on the demand of Kamloops Airport Ltd.
- 2. I understand that the yearly permit fee is non-refundable.
- 3. I shall follow all instructions received from representatives including, but not limited to, those who work for KAL, Security, and the RCMP.
- 4. I understand that the Boat Launch may have blackout periods in order to prioritize Aviation events.
- 5. I understand that Kamloops Airport Ltd. reserves the right to close the boat launch during high water if deemed unsafe.
- 6. I understand that it is my responsibility to ensure that the lock and boat launch are secured behind me.
- 7. I understand that in the event that I leave the boat launch unsecured, Kamloops Airport Ltd. may revoke my Boat Vehicle Operator Permit.
- 8. I shall not loan, give or otherwise offer the use of the pass/card, or boat launch code to any other person.
- 9. I shall visibly display the Airport Pass on the outside of my clothing on the front torso.
- 10. I shall report any loss/stolen passes immediately to Kamloops Airport Ltd.
- 11. I am aware that Kamloops Airport Ltd. will levy a replacement fee.
- 12. Fees for permit or replacement permit are subject to change at the discretion of Kamloops Airport Ltd.
- 13. I understand that in the event of an incident with an aircraft, I may be held financially responsible for any damage that may occur.
- 14. I have completed and understood the Boat Vehicle Operator Permit program, by Kamloops Airport Ltd.
