AIRPORT IMPROVEMENT FEE

All passenger aircraft with a MTOW over 4,000kg are required to pay the Airport Improvement Fee. Air Operators are required to self-report AIF passenger numbers. An invoice for the total certified aircraft capacity will be assessed and billed if self-reporting is not completed.
